WHERE: SAN BERNARDINO & RIVERSIDE COUNTIES

**SR-38 IS OPEN TO ALL TRAFFIC, INCLUDING TRUCKS AND BUSES,
IN BOTH DIRECTIONS TO AND FROM BIG BEAR**

**TRUCK AND BUSES MAY USE SR-330 TO SR-18 TO SR-38 (THROUGH FAWNSKIN)
TO BIG BEAR – UPHILL ONLY!**

TRUCKS/BUSES STILL RESTRICTED ON SR-18 FROM LUCERNE

SR-18 from Snow Valley to Paradise Way (backside) To Big Bear/Fawnskin	Open to traffic – NO CHAINS REQUIRED See above for truck/bus travel <u>May close intermittently due to conditions</u>	Snow	Until further notice
SR-18 from Lucerne to Big Bear (backside)	Open to vehicle traffic – No chains required <u>Trucks and buses restricted</u>	Snow	Until further notice
SR-38 from Angelus Oaks Big Bear Dam	Open to all traffic – No chains required	Snow	Until further notice
SR-138 from SR-173 to Miller/Dart Cyn	No chains required	Snow	Until further notice
SR-2 from Vincents Gap to ISLIP Saddle (LA County)	WINTER CLOSURE	Snow	Until further notice
SR-2 from Grassy Hollow to Vincents Gap (west of Wrightwood)	Closed until this weekend	Snow	May open by this weekend
SR-62 from Bonita to Mile Square (west of 29 Palms)	#1 lane eastbound closed	Pavement failure	Until further notice
I-10 westbound west of Jefferson	#3 LANE CLOSED	Pavement failure	Until further notice
SR-95 from I-10 to SR-62	OPEN	Tornado/Storm Damage	Until further notice
SR-95 from SR-62 to I-40	CLOSED	Storm Damage	Until further notice

No chains are required at this time on state highways on mountain routes. However, please bring chains in the event that weather changes or other roads require chains. It is also the law that you carry chains during winter.

CHAIN CONTROL REQUIREMENT LEVELS:

| W: | No Restrictions - Watch for snow on pavement. |
| R-1: | Chains are required on all commercial vehicles (trucks or buses). All other vehicles (cars, pick-ups, vans, etc.) must have either snow tread tires or chains on the drive axle. |
| R-2: | Chains are required on all vehicles except four-wheel drives with snow tread tires. Four-wheel drive vehicles must carry chains in the vehicle. |
| R-3: | Chains required - ALL VEHICLES - no exceptions. |
