DEVORE 2 – WEEKEND WORK UPDATE **POSTPONED RAPID REHAB WEEKEND WORK** **RESCHEDULED FOR NOVEMBER 10-12**

San Bernardino County – Caltrans continues the Devore 2 Pavement Rehabilitation project on Interstate 15 (I-15) near the junction of 15/215 in Devore, just south of the Cajon Pass. Rapid Rehab weekend work was postponed last weekend, November 3-5, in consideration for the Esperanza Firefighter's funerals and memorial. The Rapid Rehab weekend work will continue this weekend, November 10 through 12.

The work will begin on Friday, November 10, at 9:00 a.m. and continue to Sunday, **November 12**, at 1:00 p.m. Reference the Closure B map on our website or brochure. Closure B involves work at two connectors as follows:

Friday morning (9 am), November 10 to Sunday afternoon (1 pm), November 12:

- Southbound I-15 to southbound I-15 connector closed
- Northbound I-215 to southbound I-15 connector closed

Detours during the connector closures:

Southbound I-15 - Take I-215 south toward San Bernardino to I-10 west and reconnect with the I-15 in Ontario.

Northbound I-15 – all lanes open to traffic.

Northbound I-215 to southbound I-15: Take I-10 west to I-15 north. If you miss this detour, your last chance to exit is Devore Road. Otherwise, you will be forced to turn around to access southbound I-15 and go through the construction zone. This could result in an additional 2-3 hour delay. Caltrans plans to open the lanes on Sunday afternoon at 1 p.m. to accommodate the travelers returning from the high desert and Nevada.

ATTENTION CONCERT GOERS (HYUNDAI PAVILION): Please add extra time to your trip if you are attending the concert at Hyundai Pavilion on Saturday afternoon, November 11. **Following are some access roads to the pavilion:**

From northbound 215 use University Pkwy., Palm/Kendall, or Devore Rd.

From southbound I-15 (High Desert) use I-15 south to I-215 south, and exit Devore Rd. or Palm/Kendall.

From northbound I-15 use Glen Helen Parkway.
